Department of Students Welfare, University of Kashmir is organising an **Annual Educational Tour-2019** outside J&K State during February 2019 for the students of Kashmir University. In this connection, Heads / Directors of Teaching Departments / Institutes of University are hereby requested to kindly nominate 1 to 2 students for the said tour.

The terms and conditions of the programme are as follows:

**NOTE: FIRST PREFERENCE WILL BE GIVEN TO THOSE DEPARTMENTS WHO DO NOT ORGANISE ANY EDUCATIONAL/INDUSTRIAL TOUR OR ANY KIND OF VISIT TO OTHER STATES.**

1. Head / Director of the Department / Institute may nominate only 1 to 2 students from their respective Departments for the Tour;
2. The duration of the tour will be 13 to 16 days including Travel;
3. Each student shall be paid Rs.150/- per day as Dearness allowance;
4. Each student shall have to deposit Rs.3500/- to meet the accommodation charges;
5. Each student shall submit an undertaking that they will travel at their own risk and responsibility;
6. The Group is expected to visit various prominent Universities / Institutions and Historical places in Delhi, Rajasthan, Punjab & Haryana (Delhi University, Jamia Millia Islamia university, Jamia Hamdard, Rajasthan University, Banastahli University, Ajmeer University, Udaipur, Jodhpur , Punjab University Chandigarhh and GNDU, Amritsar.
7. Interested students may please be directed to fill in the enclosed format and submit the same in the Department of Students Welfare duly recommended by Head / Director of the Department / Institute.
